Walk Audit and Travel Plan Successes

Over the past 3 years, the Resource Center has helped to facilitate numerous Walk Audits and has drafted 16 SRTS Travel Plans.

Walk Audits bring community stakeholders to the school to observe the dismissal process and assess the walkability and bikeability of the school campus. The group identifies infrastructure and safety improvements that will help increase the safety of student walkers and bicyclists and hopefully allow for more students to walk or bicycle to school. Engineering strategies are then written in a plan and prioritized by the team.

Drafting a SRTS Action Plan takes the Walk Audit process one step further by identifying recommendations and strategies to address the other 4 Es of SRTS: Education, Encouragement,

S.C. Safe Routes to School Funding

The SCDOT Safe Routes to School (SRTS) program is currently accepting applications for SRTS infrastructure projects. The SCDOT SRTS Program has designed a competitive application to assess the need for Safe Routes to School programs at schools in South Carolina. The need is determined through evaluation of current student travel patterns, potential participation, physical and perceived barriers to SRTS, traffic issues, crash data, an exhibited existing interest in SRTS, and understanding of the comprehensive nature of SRTS.

Any school with grades K-8, a school district, a municipality, or any other government entity may apply, but selected schools must be a partner of the SRTS Resource Center in order to

be considered for funding. Government agencies or organizations may apply on behalf of a school. An application for funding must represent only one (1) eligible school, and only one application per school per funding cycle is eligible. Eligible schools must have been in operation for at least two years prior to the application deadline. Previous SRTS infrastructure awardees and schools built within the last two years are ineligible.

SCDOT will administer and oversee the infrastructure project, and the SC SRTS Resource Center will continue to provide non-infrastructure services and programs.

Applications for SC Safe Routes to School funding are now available. The deadline for applications is May 16, 2014, and no applications will be accepted after that date.

The SC Safe Routes to School Resource Center is calling for self-nominations from schools requesting professional planning assistance for a Safe Routes to School (SRTS) Action Plan. Only a handful of schools will be selected from across the state to receive this free resource. Your Action Plan will help to establish a long and short-term comprehensive SRTS Plan for the school and surrounding community. Your school will be chosen based upon its interest, its current work with SRTS, and the current condition of its surroundings.

The Action Plan will include recommendations, strategies and activities and will outline the 5 Es of SRTS (Engineering, Evaluation, Education, Encouragement, and Enforcement).

Spotlight on a Friend: Safe Kids Sumter

Safe Kids Sumter is one of the many Safe Kids coalitions in South Carolina partnered with the Resource Center. Safe Kids Sumter recently participated in a Safety Assessment at Wilder Elementary. Their coordinator was able to express the importance of proper child restraints and the use of safety belts to faculty members during the Safety Walk Audit. The discussion led to community members at the table exploring ideas of how to incorporate all transportation modes by educating and aiding parents in purchasing proper restraints. Safe Kids Sumter offers a variety of services such as child passenger safety seat checks, child passenger safety trainings, and bicycle rodeos which can be coordinated at your school.

Every year, Safe Kids Sumter host Kid's Fest and all elementary students are invited to attend this two day event. This year it will be held on April 15th-16th from 8:30 a.m. to 1:00 p.m. at the Sumter Civic Center. Students will learn about fire safety, bike safety, pedestrian safety, and much more!
